Instructions for Affiliation by Demit package

What to do:

You (the petitioner) fill out all of **Form 11** and return it to Broad Ripple Lodge for presentation. **Form 11** must be accompanied by your check or money order in the amount of **\$10.00**. Your check or money order will not be cashed until you are elected. If your petitioning fee is not received with your petition, your petition will be held until the fee is received.

You must provide a demit from your lodge, certified by the Grand Secretary of your Jurisdiction if it is outside of Indiana.

Submit the background check authorization at: https://www.indianafreemasons.com/verification-background-check

- 1. Scroll down to the link that says <u>Background Verification Site</u>
- 2. Click <u>Apply Now</u>
- 3. Select MEMBERSHIP (\$14.45) and click Continue
- 4. Fill out the form, agree, and click <u>Continue</u>
- 5. Finish page 2 of the form, and for Location specify Broad Ripple

The verification process will NOT work properly on a cell phone or tablet for security reasons. Please use a computer when filling out your information.

Please note -- the petitioning fee does not include Lodge Dues!

In addition to the petitioning fee, you will have to pay Lodge dues -- but not until after you have been elected to become a member of the Lodge. Broad Ripple Lodge's annual dues as of January 1, 2024, are \$180. Pro-rata dues are calculated starting on the first day of the month you are elected:

However -- keep in mind that dues for the next year are due on January 1. So if you are elected in December, don't let the zero dues fool you, because you will owe a full year's dues on January 1.
