Instructions for Plural Membership Petition package

### What to do:

You (the petitioner) fill out all of **Form 16P** and return them to Broad Ripple Lodge for presentation. **Form 16P** must be accompanied by your check or money order in the amount of **\$30.00**. (A small \$5.00 portion of this fee is transmitted to the Grand Secretary after you are elected to plural membership.) Your check or money order will not be cashed until you are elected. If your petitioning fee is not received with your petition, your petition will be held until the fee is received.

You must also fill out **Form 15P** and send it to your own Lodge. If you belong to more than one Lodge, you must send a filled-out copy of **Form 15P** to each Lodge to which you belong. If one or more of your Lodges are in foreign jurisdictions (that is, not chartered under the Grand Lodge of Indiana F. & A.M., but chartered under a Grand Jurisdiction that is in amity with our Grand Lodge), please return the **Form 15P** for those Lodges to Broad Ripple Lodge #643 and we will transmit them to your foreign jurisdiction Lodge(s) via our Grand Secretary.

1. Scroll down to the link that says Background Verification Site
2. Click Apply Now
3. Select MEMBERSHIP (\$14.45) and click Continue
4. Fill out the form, agree, and click Continue
5. Finish page 2 of the form, and for Location - specify **Broad Ripple**

**The verification process will NOT work properly on a cell phone or tablet for security reasons. Please use a computer when filling out your information.**

**Please note -- the petitioning fee does not include Lodge Dues!**

In addition to the petitioning fee, you will have to pay Lodge dues -- but not until after you have been elected to become a member of the Lodge. Broad Ripple Lodge's annual dues as of January 1, 2024, are \$180. Pro-rata dues are calculated starting on the first day of the month you are elected:

However -- keep in mind that dues for the next year are due on January 1. So if you are elected in December, don't let the zero dues fool you, because you will owe a full year's dues on January 1.
