Instructions for Membership Transfer Petition package

#### What to do:

You (the petitioner) fill out all of **Form 16** and return it to Broad Ripple Lodge for presentation. **Form 16** must be accompanied by your check or money order in the amount of **\$10.00**. Your check or money order will not be cashed until you are elected. If your petitioning fee is not received with your petition, your petition will be held until the fee is received.

You must also fill out Form 15 and send it to your current lodge that you are transferring from.

You should also send your Lodge a copy of **Form 17** for their convenience in reporting your Masonic credentials back to Broad Ripple Lodge.

Submit the background check authorization at:

- 1. Scroll down to the link that says <u>Background Verification Site</u>
- 2. Click Apply Now
- 3. Select MEMBERSHIP (\$14.45) and click Continue
- 4. Fill out the form, agree, and click Continue
- 5. Finish page 2 of the form, and for Location specify **Broad Ripple**

The verification process will NOT work properly on a cell phone or tablet for security reasons. Please use a computer when filling out your information.

### Please note -- the petitioning fee does not include Lodge Dues!

In addition to the petitioning fee, you will have to pay Lodge dues -- but not until after you have been elected to become a member of the Lodge. Broad Ripple Lodge's annual dues as of January 1, 2024, are \$180. Pro-rata dues are calculated starting on the first day of the month you are elected:
